

FACTS	WHAT DOES COUNTRY HERITAGE CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security Number and income • Account balances and payment history • Credit history and credit scores When you are no longer our member, we continue to share your information as described in this notice.
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Country Heritage Credit Union chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does Country Heritage Credit Union share?	Can you limit this sharing?
For our everyday business purposes – such as to process your transactions, maintain your account(s), respond to court orders and legal investigations or report to credit bureaus	Yes	No

What we do	
How does Country Heritage Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Country Heritage Credit Union collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> • Open an account • Apply for a loan • Use your debit card • Make deposits or withdrawals from your account • Provide account information We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account – unless you tell us otherwise.

Affiliates	Companies related by common ownership or control. <ul style="list-style-type: none"> • <i>CUNA Mutual Group, 5910 Mineral Point Rd. Madison, WI 53705, 1-800-356-5644</i> • <i>Honor Credit Union, 2920 Lakeview Ave., St. Joseph, MI 49085, 269-983-6357</i>
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> • <i>Country Heritage Credit Union does not share with non-affiliates so they can market to you.</i>
Joint Marketing	A formal agreement between non-affiliated financial organizations that together market financial products or service to you. <ul style="list-style-type: none"> • <i>Country Heritage Credit Union does not jointly market.</i>
